

BIOGRAPHIES OF PRESENTERS

Alphonso David, Esq., was appointed Deputy Secretary for Civil Rights, the first position of its kind in the state, in January 2011. In this role, he is responsible for a full range of legal, policy, legislative and operational matters affecting civil rights and labor statewide. Prior to joining the Governor's Office, Mr. David served as Special Deputy Attorney General for Civil Rights for the Office of the New York State Attorney General, where he supervised assistant attorneys general and managed strategic planning, case development, and policy analysis. He also served previously as Deputy Commissioner and Special Counselor at the New York State Division of Human Rights, litigation associate at the law firm Blank Rome LLP, and staff attorney at the Lambda Legal Defense and Educational Fund. At Lambda, Mr. David prosecuted and defended precedent-setting civil rights cases across the country affecting lesbian, gay, bisexual and transgender individuals and those living with HIV, including marriage, parenting rights, discrimination in schools and access to health care. He is also an Adjunct Professor of Law at Cardozo Law School and Fordham University Law School, where he teaches "Constitutional Law: Sexuality and the Law." Mr. David is a graduate of the University of Maryland and Temple University School of Law and served as a judicial clerk to the Honorable Clifford Scott Green in the U.S.District Court for the Eastern District of Pennsylvania.

Robert E. Beloten, Esq., is Chair of the New York State Workers' Compensation Board. He has been a law judge at the Board from 1988-1996 and 2000-2009. From 1996-2000, he was a Senior Law Associate at the law firm of Keating and Klein of Syosset, New York, a firm specializing in health care law. Between 1996-2000 Mr. Beloten served as a part-time hearing officer in the New York Supreme Court in Mineola, New York, conducting hearings on property assessments on residential properties in Nassau County, and he was an arbitrator and mediator for the Workers' Compensation Alternative Resolution Panel for the Construction Trade in Albany, New York. From 1985-1988 he was an assistant counsel for the New York State Racing and Wagering Board. He instituted administrative proceedings to ascertain violations of statutes, rules and regulations governing racing and pari-mutuel wagering, which include the administering of controlled and/or prohibited substances to horses, as well as the failure of employers to provide their employees with required workers' compensation insurance. Mr. Beloten clerked for New York Civil Court Judges Herbert A. Posner and Pearle Appelman from 1981-1984, in Kew Gardens. He has lectured extensively throughout New York on medical law and workers' compensation. He earned his law degree from the Hofstra University School of Law and a Bachelor of Arts degree from the University of Maryland, College Park, with concentrations in History, Government and Politics and Zoology.

KEYNOTE

Awardee of the Frances Perkins Award

Jamila Wignot is an award-winning, Brooklyn-based filmmaker. Her body of work includes Town Hall, a feature-length coproduction with ITVS, about the Tea Party movement (Seattle International Film Festival '13); and for PBS the Peabody Award-winning films, *The African Americans: Many Rivers to Cross and Triangle Fire;* and the Emmy-nominated *Walt Whitman.* Ms. Wignot also produced *The Rebnquist Revolution*, the fourth episode of WNET's series *The Supreme Court,* which was an IDA Best Limited Series winner. She is currently directing one hour of the six-part women's series *Makers* and is a producer/director on a documentary film about the playwright Lorraine Hansberry. Her other producing credits include *Jesse James* and *Massie Affair,* which aired on WGBH's American Experience. Prior to her work as a producer and director, she worked on other PBS programs, including *Reconstruction: The Second Civil War* and the series *Race: The Power of an Illusion.*

Awardee of the Dr. Stephen Levin Award

Robert Bruce Goldberg, DO, is President of the Organization of State Medical Association Presidents (OSMAP) of the American Medical Association (AMA) and has served as past president of the Medical Society of the State of New York. He also is Dean and Professor at the Touro College of Osteopathic Medicine, New York City, New York. As OSMAP President, Dr. Goldberg looks to advance the work of this non-profit organization to further the aims and ideals of organized medicine by advocating for patients and striving to enhance medical education and clinical opportunities at the undergraduate and graduate levels. He previously served as the first Associate Dean for Community Medical Affairs and Advocacy for Touro College of Osteopathic. The mission of Touro College of Osteopathic Medicine places special emphasis on teaching and learning in the areas of primary care and the holistic approach to the patient. The College is committed to identifying and recruiting students who have specific interest in practicing underserved communities and addressing health care disparities. A graduate of Rutgers College, Dr. Goldberg earned his DO degree at the Philadelphia College of Osteopathic Medicine, Philadelphia, PA, where he served his internship. He trained in Physical Medicine and Rehabilitation Medicine at St. Vincent's Hospital and Medical Center of New York City, and he serves as attending physician in the Department of Physical Medicine and Rehabilitation at Beth Israel Medical Center, New York City. He is certified by the following boards: American Osteopathic Board of Rehabilitation Medicine, American Board of Physical Medicine & Rehabilitation, and the American Board of Neuromuscular and Electrodiagnostic Medicine. Dr. Goldberg has been a medical educator for more than twenty years, training medical students, interns and residents. In April 2008 he was honored by the Medical Students Section of the Medical Society of the State of New York and received the Charles D. Sherman, M.D., award for extraordinary assistance, availability and support provided to medical students. He received the National Hispanic Health Foundation Leadership Award on December 1, 2011. Dr. Goldberg received a citation on April 12, 2008, from Governor David Paterson, acknowledging his dedication to the advancement of medicine and the improvement of Healthcare for all peoples. He has received many awards and honors, including the Clara Lemlich Public Service Award by the Triangle Shirtwaist Factory Fire



Memorial for work and efforts in calling attention to and participation in the reform of workers' compensation and improvement of occupational safety in New York State March 25, 2008; the New York Society of Physical Medicine & Rehabilitation Outstanding Service Award, presented September 5, 2007; the Webber Memorial Award presented by the American Osteopathic College of Physical Medicine & Rehabilitation, for contributions to the field of Physical Medicine & Rehabilitation, September 2007; Physician of the Year Award from the New York State Osteopathic Medical Society, April 21, 2007, for Service & Dedication to Patients, Colleagues and the Progress of Osteopathic Medicine in the State of New York; and a Certificate of Appreciation from the Bronx County Medical Society for Distinguished Service, April 14, 2007. He received a citation from Governor Pataki on June 16, 2000, for presidential efforts for alliances forged with consumer groups, legal organizations, and other medical associations on behalf of medical coverage for the underserved and advocacy for reform of workers' compensation laws. Dr. Goldberg received a citation from C. Virginia Fields, President, Borough of Manhattan, for outstanding achievements in the fields of physical medicine and rehabilitation; in recognition of professional leadership in improving communication among consumer groups, legal organizations, third-party payers and others to advance the goals of expanded medical coverage for the uninsured and high-quality patient care; and in appreciation for service as the 161st president of the New York County Medical Society. He was selected as one of the Best Doctors in New York by New York Magazine (1998, 1999, 2000) for Physical Medicine and Rehabilitation, Sports Medicine and Manipulation. He also has been listed in *How to Find the Best Doctors in New York Metro Area* by Castle, Connolly Medical LTD 1997-2013. Most recently he was chosen as one of the New York Super Doctors as published by the New York Times (2011-2013). He was elected President of the Medical Society of the State of New York in 2007. He served as the Co-Chairman of the Carrier Advisory Committee for the Centers for Medicare and Medicaid Services, having served on the committee 1993-2010, since its inception. He is an advisor to the Governor's Task Force for Workers' Compensation Reform, and he served on the Governor's Task Force for the Office of Medicaid Inspector general. He is a Member of the American Academy of PM&R (AAPM&R) and was Chairman of the Medical Practice Committee for that organization. Dr. Goldberg served as the AAPM&R Representative to the RUC Committee for the AMA and serves as an advisor to the CPT Committee of the AMA for the AOA. He serves as Chair of the New York delegation to the AMA House of Delegates and is a Delegate to the AOA House of Delegates. He has served on governor's task forces for workers' compensation reform for the administration of Governors Paterson, Spitzer and Pataki. He is Past-President of the American Osteopathic College of Rehabilitation Medicine. He served as Chairman of the Managed Care Task Force for the New York County Medical Society, which was responsible for the first of a series of successful litigation to ensure access for patients throughout the New York and the Nation.

LEGAL TRACK

Ten Most Significant Cases in Workers' Compensation History

David Wertheim, Deputy General Counsel

David F. Wertheim, Esq., is the Deputy General Counsel for the Workers' Compensation Board. He received his J.D. from Cardozo Law School in 1991 and thereafter was admitted to practice in New York. Prior to joining the Board, he worked in private practice, and as an attorney for State Insurance Fund. He has been with the Board since 1997 in various capacities, including staff attorney for the Uninsured Employer's Fund, Deputy Director of the Administrative Review Division, Senior Law Judge for the Albany district, and, since 2011, Deputy General Counsel. Mr. Wertheim has presented many Continuing Legal Education Classes for the Board, the New York State Bar Association, the Appellate Division, Third Department, and the New York State Attorney General's Office.

The Issue Resolution Spectrum

Panel led by Madeline Pantzer, Chief of Adjudication

Madeline H. Pantzer, Esq., is currently the Board's Chief of Adjudication. She is a graduate of the University of Wisconsin, Madison, where she majored in History, and New York Law School. She worked in private practice and as an Administrative Law Judge with the City of New York prior to joining the WCB in 1998. She has served as a Workers' Compensation Law Judge in Brooklyn and Manhattan, the Senior Workers' Compensation Law Judge for the Albany District and the Chief of the Administrative Review Division.

Eric London, **Esq.**, is a conciliator in the Adjudication Bureau of the Board. He has been with the Board since 1998. He is a graduate of Thomas Cooley Law School and Ithaca College. He is admitted to the New York State Bar, New Jersey Bar, and all four New York State Federal Districts.

Marjorie Leff, **Esq.**, is a graduate of Binghamton University and New York University School of Law and admitted to practice in New York State. She worked in private practice at a labor law firm and as an administrative law judge at the New York State Department of Labor/Unemployment Insurance Appeals Board. Since 1997, she has been an assistant attorney general at the NYS Office of the Attorney General in the Labor Bureau. In this capacity, she represents the Commissioner of Labor in various matters, including representing the Workers' Compensation Board in litigation before the courts relating to decisions made, or actions taken by the Board, in its quasi-judicial capacity.

D. Jeffrey Romeo, Esq., has been employed by the Workers' Compensation Board in the Albany district since November 1992, presently as a workers' compensation law judge. Originally hired as a Conciliator, Judge Romeo has served as an associate attorney, team leader in appeals, albany senior law judge, principal draftsperson in the 1998 Plain English and decisional reformatting project, participated as a CLE presenter on numerous occasions (including several annual Judge's Conferences) and most recently served as an adjudication representative on the medical team for the Business Processes Reengineering (BPR) project. He is a 1982 graduate of the University of Buffalo and a 1985 graduate of The South Texas



College of Law. He has been licensed to practice law in New York since January 1986. Judge Romeo was previously employed as an associate attorney at the law firm of Walsh and Hacker, followed by a two year volunteer service in the United States Peace Corps as a legal advisor to the Malaita Provincial Government in the Solomon Islands. Upon return to the United States he worked as an associate attorney at the law firm of Sullivan, Rehfuss, Cunningham and Brennan before coming to the Board.

Cheryl M. Wood, Esq., is the director of the Administrative Review Division in the Office of General Counsel of the Workers' Compensation Board. Prior to assuming this position in 2011, she served in several different management positions. Before joining the Board, she served as Assistant Counsel with the Governor's Office of Regulatory Reform, dealing with a variety of issues and agencies. During this period she also served as Attorney for the Town of Durham. Before joining state service, Ms. Wood worked for Kingsley and Towne, P.C. Ms. Wood graduated from N.Y.U. School of Law and Vassar College. She is admitted to practice in New York and the Northern District of New York. She is a member of the New York State Bar Association and the American Bar Association.

Combating Health Care Fraud in the Workers' Compensation System

Paul D'Emilia, Fraud Inspector General

Paul D'Emilia, Esq., is the Fraud Inspector General for the Workers' Compensation Board, and has been with the Board for two years. Prior to his current position, Mr. D'Emilia was in private practice, and before that, a prosecutor with the Kings County District Attorney's Office for fourteen years, where he conducted more than 40 felony trials and 10 homicide trials. For two years, Mr. D'Emilia served as the resident legal advisor at the United States Embassy in Albania on behalf of the U.S. Department of Justice, Office of Overseas Prosecutorial Development Assistance and Training.

Ramona Tanabe, Deputy Director WCRI

Ramona Tanabe, Esq., is the Deputy Director and Counsel at the Workers Compensation Research Institute (WCRI) in Cambridge, Massachusetts. She has been with WCRI since 1996 and has served in her current role since 1999. As Deputy Director and Counsel, Ms. Tanabe oversees the data collection and analysis efforts for numerous research projects, including the CompScopeTM Multistate Benchmarks, which measure and benchmark the performance of a growing number of state workers' compensation systems.

State of the System Today: Perspectives from Participants

Panel of System Stakeholders led by Hashim Bello, Director of Policy and Research

Hashim Bello, Esq., is the Director of the Policy and Research Bureau of the Workers' Compensation Board, where he oversees quantitative and qualitative research into policy and process issues in the New York workers' compensation system. The Policy & Research Bureau delivers information to improve workplace safety and health, enhance workers' compensation system performance and inform public policy and program administration. The Bureau actively monitors and researches issues related to injured worker health care and benefits, analyzes stakeholder impact of procedural and legislative reform, and monitors and surveys other American and international jurisdictions for cutting edge improvements in workers' compensation administration and their applicability to New York. Mr. Bello has degrees in Mathematics and Law.

Lev Ginsburg, Esq., Director of Government Affairs for the Business Council of New York State, is a graduate of the University of Buffalo and the Benjamin N. Cardozo School of Law. Prior to his legal education, Mr. Ginsburg served as a staff member for U.S. Senator Arlen Specter, a political campaign coordinator and marketing director. He was a staff attorney with T-Mobile Communications, handling real estate leasing and title issues for mobile communication antennae sites. Most recently, he served for seven years as attorney and staff supervisor with the former Governor's Office of Regulatory Reform (GORR). At GORR, Mr. Ginsburg handled stakeholder outreach and regulatory oversight over many state agencies. Although his regulatory oversight work covered a broad range of issue areas, his main focus is health and labor regulations.

Steven Minkowsky was appointed as Deputy Director of Monitoring, Audit and Enforcement, Maine Workers' Compensation Board and the Maine State Executive Branch on March 3, 1993. The focus of this newly created position was to implement the Monitoring, Audit and Enforcement (MAE) Program pursuant to the Maine Workers' Compensation Act of 1992. The success of this program contributed to reduced litigation, enhanced performance measurements, and a reduction in employer premiums. The MAE Program has received national recognition. Mr. Minkowsky also served as the agency legislative liaison and the human resources representative at the workers' compensation board. After serving in a variety of Maine state government positions for more than 33 years, he retired on February 28, 2011.

Jeff Stark has been an active member of the Labor Movement in Albany over the last 18 years. Born in Amsterdam, NY, his parents taught him at an early age the value of hard work and caring for your community. In 1998 he was appointed an organizer for District Council 9 Painters and Allied Trades, then was elected business representative for 11 counties in upstate NY. He currently serves as president of the Greater Capital Region Building Trades Council and has negotiated project labor agreements worth more than \$14 billion. Mr. Stark has held many union offices for the Painters and is past Vice President and Treasurer of the Capital District Area Labor Federation. He is a member of the Capital Region Economic Development Council since 2012. He is an active member of his community and former Second Ward Supervisor in Montgomery County. Mr. Stark also serves as Labor Representative for Fulton-Montgomery-Schoharie Workforce Investment Board and as a Board Member for American Labor Studies Center.

Mary Beth Woods is the Acting Executive Director for the Workers' Compensation Board. From July 1998 she served as the Director of Financial Administration and the Director of Licensing. She is Chair of the Governor's Task Force on Group Self Insurance, serves as a board member of the Compensation Insurance Rating Board, and is a committee member of the Underwriting Committee of the Department of Financial Services. The Best Accident (The One that Never Happens)
