



NYS Claims Release EDI 3.1 FROI/SROI Change 02 Required

Revised 7/21/2023

The New York State Workers' Compensation Board (Board) is transitioning to the International Association of Industrial Accident Boards and Commissions (IAIABC) Claims Electronic Data Interchange Release 3.1 (Claims EDI R3.1) standard. This document provides a quick reference on the Data Element Severity Codes which New York is requiring to trigger the 02 Maintenance Type Code (MTC) in both the First Report of Injury (FROI) and Subsequent Report of Injury (SROI) for FROI/SROI-02 transactions.
