

Summary of Changes to Medical Treatment Guidelines for Mid and Low Back, Neck, Shoulder and Knee Injuries and Carpal Tunnel Syndrome May 27, 2014

Revisions to General Principles in all Medical Treatment Guidelines

- 1. Removed General Principle A.8, "Six-Month Time Frame" with consequent renumbering of General Principles.

- 3. Added "Intrathecal Drug Delivery (Pain Pumps)" to list of procedures requiring prior authorization in General Principle A.14 (now A.13), "Pre-Authorization."
