- As posted in Revised Subject Number 046-1319, the Board has targeted **January 24, 2022**, as the date by which trading partners must transition to Claims EDI R3.1 for submissions to New York State.

eClaims Topics

WCIO Nature of Injury

- WCIO Nature of Injury (Code 38 - Adverse reaction to a vaccination or inoculation) to address ANY adverse reaction to ANY vaccination was added on 3/8/2021 as directed by IAIABC.

eClaims Topics

- Claim administrators need to file their suspensions even if they made one payment and voided it.
- Scenario:
 - Suspension was filed on 12/11/2020. The SROI-RB triggered in error when the attorney fee was paid.
 - Since you filed the RB in error you will have to file another suspension. You can use Reduced Benefit Amount Code- D (Decrease in Indemnity), fix the 050 Benefits reported in error, use 880 Voided Benefit Check Recovery and the Suspension Narrative for an explanation.

Claims EDI R3.1 Updated Documents

■ NYS R3.1 Event Table

- This table defines the Maintenance Type Codes (MTCs) for the submission of FROI and SROI events.

■ NYS R3.1 Element Requirements

- This table defines the required data elements for each MTC, or event, that the Board expects to receive for First Report of Injury (FROI) and Subsequent Report of Injury (SROI) filings.

■ NYS R3.1 Edit Matrix

- This table defines the edits that will be applied to the data elements and events defined in the Event and Element Requirements Tables.

Claims EDI R3.1 Updated Documents

- NYS eClaims EDI R3.1 Change Log
 - This document summarizes the changes in the published tables comparing March 15, 2020, to June 12, 2020.
- NYS FROI-SROI 02 Transaction Processing in Claims EDI R3.1
 - This document is meant to be a reference guide on how to process a FROI-SROI 02.
