This is to inform you that Long Island Hand & Orthopedic has been approved to provide products of ambulatory surgery services. The Workers' Compensation Board has issued an Ambulatory Surgery Fee Schedule for your facility (attached).

This schedule has been adopted pursuant to Section 13, subdivision (a) of the Workers' Compensation Law and constitutes Sections 329.4 and 329.5 of Title 12 of the Compilation of Codes, Rules and Regulations of the State of New York. The schedule covers ambulatory surgery charges effective June 23, 2009 – August 31, 2009 for services to patients under the Workers' Compensation Law, the Volunteer Firefighters' Benefit Law, the Volunteer Ambulance Workers' Compensation Benefit Law and the Comprehensive Motor Vehicle Reparations Act.

The schedule was prepared using the New York State Products of Ambulatory Surgery (PAS) methodology with the reimbursement level set at 150% of the rate promulgated by the New York State Department for Medicaid patients.
