

## Statement explaining why a revised Regulatory Impact Statement is not required

A revised Regulatory Impact Statement is not required because the changes made to the last published rule do not necessitate revision to the previously published document. The changes to the text clarify that assessments are imposed against employers but often remitted to the Board by the employer's insurance carrier. This change does not affect the meaning of any statements in the document.
