SUBJECT: Revisions to Solicitation (Revised October 23, 2018)

TO PROSPECTIVE BIDDERS:

The above-referenced RFP and any applicable attachments and exhibits have been amended to include the changes outlined below. Amendments are reflected in the revised attachments and exhibits dated October 23, 2018; **please use this revised document when submitting your proposal.**

The following summary of amendments is provided for your convenience:

- Attachment 20 – Minimum Bidder Qualifications – Qualification #2 is deleted in its entirety and replaced with the following:
 - **Qualification 2:** Bidder must be able to cite project(s), which were fully completed in the past five years (i.e., in the warranty period or later), where the Bidder implemented a new information system(s) that collectively included the following:
 - Process transformation;
 - Claims management system;
 - Migration of a legacy system to an n-Tier system; and
 - External agency system interfaces.

These requirements may be met by multiple projects.

- Attachment 23 – Requirements Traceability Matrix – 2 new requirements have been added:
 - **Section 5.2 – Solution Design – Requirement #472** – The Contractor shall design the solution that will provide availability 24 hours a day, 7 days a week and 365 days a year (24x7x365) with a 99.99% uptime availability.
 - **Section 8.2 – Features – Requirement #473** – The Contractor shall be responsible for upgrading the WCB's current IAIABC Claims EDI version 3.0 to the current IAIABC Claims EDI version (currently 3.1) including the migration of the eClaims Sybase database structures to the new BIS database platform.
- Exhibit 4 – Technology Solution Concept – Board Applications and support software components – eClaims – Integration Scenario is deleted in its entirety and replaced with the following:
 - The WCB's eClaims platform must be upgraded to the current version of the IAIABC Claims EDI standard (currently 3.1). The current eClaims Sybase database objects must be migrated to the BIS database platform. The IAIABC FROI/SROI transactions will need to be applied to the new BIS system. The method of integration will be determined during Design activities and approved by NYS.

- Exhibit 8 – ITS Experience Design Approach – Accessibility
 - The web accessibility standard is changed from WCAG 2.0 to WCAG 2.1.

All other terms and conditions of the Solicitation remain unchanged. All bids shall be considered based on these amendments.
