

FROI/SROI-02 Change transactions

When you add (A), update (U), remove (R), or delete (D) information on the FROI/SROI-02, WDE will automatically detect the change and present you with a confirmation message that includes the Data Element and Reportable Change Code. If the information appears correct, you may select **Continue.** If any errors are returned on the O2 Change transaction, you may be presented with an error message that contains "Data Elements missing in Change Variable Segment." This error means there are other data elements missing on the transaction. You will need to review the **NY Requirement Tables – EDI R31** page to determine the missing field(s).

In the example below, DN0068 (Initial RTW Date) was added to the FROI-02 and returned an error that data elements were missing. The Population Restriction (found on the Edit Matrix – Population Restrictions tab) for 02 Change, pictured below, requires that DN0403 (Initial RTW Type Code) and DN0404 (Initial RTW Physical Restrictions Indicator) be populated on the 02 Change transaction if DN0068 (Initial RTW Date) is present. Once you populate the additional required fields and resubmit the transaction, it should now be accepted successfully.

Reminder: Timely FROI Filings

- Claim Administrators should ensure timely filings of FROI's for the Board being properly notified of the correct claim administrator
- Avoids untimely filing penalties being assessed from the Board's Monitoring Unit
- Provides information to the Board's OnBoard application ensuring prior authorization requests are given to the correct claims administrator

Most Frequent Errors Returned During the Past 90 Days



Population Restriction 0085-064A

This most common error for the last 90 days as well as the top error for 2022 was a carryover edit from eClaims R3.0. The population restriction is intended to prevent a new DN0085 (Benefit Type Code) from being introduced as a sweep benefit if not previously submitted as an Event Benefit or a SROI-UR(G)/SA included the Benefit Type Code. This is based on the IAIABC Claims EDI Section 4 rules.

The second most common error returned in the past 90 days is an eClaims R3.0 carryover to ensure that DN0075 (Agreement to Compensate Code) is sent as "With Liability" after the Board has issued a Notice that the case has been established with an ANCR/ODNCR finding in accordance with § 21-a.

The fourth most common error returned in the past 90 days is another eClaims R3.0 carryover. This edit is listed on the SROI Element Requirement Table for Payee (DN0217). Payee is required when Number of Payments (DN0283) > 0.

Population Restriction 0418-064A

- The fifth most common error during the past 90 days is Population Restriction 0418-064A.
- This edit forces SROI-SX transactions to be rejected when a DN0418 (Suspension Reason Code Full) other than "SJ" is reported on any claim where §21-a had been applied.
