In the Administrative Review Division, 1,052 6 applications were received, 1,889 decisions were 7 processed and there are currently 6,856 decision -- I mean, applications pending. In Legal Affairs 8 9 Division, in the Legal Affairs Division, 113 Full 10 Board Review applications were received, 105 were 11 processed and there are currently 223 applications 12 pending.
